



FMC Ice Sports Hockey Waiver Updated 5.2025

General

1. For the safety and enjoyment of all skaters, FMC Ice Sports requires individuals to follow FMC rules, etiquette and codes of conduct on all sessions. Individuals who do not comply with arena or program rules may be asked by staff to leave the ice and/or facility and may lose skating privileges.
2. Purchase of FMC hockey programs signifies agreement to all applicable waivers.
3. Full Equipment is required for all participants. For a complete and updated list of equipment requirements visit the FMC website at www.fmcicesports.com.
4. All participants must pay appropriate fees prior to skating.
5. Skaters are responsible for their conduct both on and off the ice.
6. All FMC Adult Hockey programs are intended for skaters 18 years and older unless otherwise noted. Skaters under the age of 18, will only be admitted with the Program Instructors approval. Parental consent via this waiver is also required.

Waiver

In consideration of being allowed to participate in any way in FMC Hockey programs, related events and activities of FMC Ice Sports, I as the participant or parent/guardian of the minor participant in my care, acknowledge, appreciate, and agree that:

1. I, do hereby acknowledge that in consideration of myself or my child participating in any way in FMC Ice Sports programs, as a participant or a spectator, may be exposed to risk of injury that is inherent in ice skating programs and/or exposure to communicable diseases inherent in activity. I hereby acknowledge that Facility Management Corporation and FMC Ice Sports staff are not responsible for any damage, injuries or illness that result from my/their participation in this program. I grant to FMC Ice Sports, its representatives and employees the right to take photographs of myself/my child in connection with the above-identified ice sports program. I agree that FMC Ice Sports may use such photographs for any lawful purpose, including for example such purposes as publicity, illustration, advertising, and web content; and,
2. The risk of injury from the activities involved in this program is significant, including the potential for permanent paralysis and death, and while particular rules, equipment, and personal discipline may reduce this risk, the risk of serious injury does exist; and,
3. I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown of my participation in FMC Hockey Programs, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume full responsibility for my participation; and,
4. I willingly agree to comply with the stated and customary terms and conditions for participation in FMC Hockey Programs. If, however, I observe any unusual significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of the nearest official immediately; and,
5. I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, HEREBY RELEASE, INDEMNIFY, AND HOLD HARMLESS FMC Ice Sports and Facility Management Corporation, their officers, officials, agents and/or employees, other participants, sponsoring agencies, sponsors, advertisers, and, if applicable, owners and lessors of premises used to conduct the event ("Releasees"), WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, or loss or damage to person or property, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE, to the fullest extent permitted by law.

I HAVE READ THIS RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY MAKING THIS PURCHASE, AND DO SO FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT.
